

Terms of Use

The Federation of Medical Women (FMWC) is making this forum available to registered members to foster a positive exchange of ideas on issues that are of interest to Canadian physicians, students and health professionals. By participating in the FMWC Members' Forum you agree, without limitation or qualification, to be bound by and to comply with, these Terms of Use. Please read it carefully.

We may revise these Terms of Use from time to time. Your continued use of the Members' Forum constitutes your acceptance of any such revisions. We encourage you to review this document regularly.

'You' and 'your' refers to each physician or medical student or health professional who is a registered member of FMWC and who is granted a username and password to use the Members Forum.

'We' and 'our' and 'us' refers to the FMWC.

1. **About the Forum.** The Members' Forum is provided to FMWC members as a place where they can go to exchange information and ideas with colleagues. The forum will allow you to form connections with your colleagues and easily share information and collaborate on topics of interest to you.
2. **Membership.** All FMWC members are eligible to participate in the Forum.
